Potential Action Item: Proposed Rule for Introduced Species for GFNMS/MBNMS

Discussion:

- “Introduced” should be defined and differentiated from “non-native” and “invasive”.
- Implications for Tomales Bay Aquaculture and permitting current leases (as of the “effective date of these regulations”) will be grandfathered in.
- The proposed rule will bring consistency between policies of the state and federal governments.
- This rule applies to nonnative introduced shellfish species grown for commercial means in the sanctuary. Any request to amend or extend the geography or species cultivated is subject to this rule.
- Randy Lovell-Aquaculture Coordinator at California Department of Fish and Game attended and said that the state wants to look at introduced species issues on a case-by-case basis and have a collaborative process with the Sanctuary on management.
- The Programmatic Environmental Impact Report (PEIR) will be released within months. Over 300 comments must be addressed.
- SAC members asked several questions about existing leases in Tomales Bay, including what would trigger a review of a current lease. Aquaculture lease areas are designed based on the requests for leases. Therefore there are many lease areas that currently don’t have active aquaculture. There are currently 12 leases and 6 operators. If a grower wants to do something that would amend the lease (such as expand, change shape, or grow new

species), then this would trigger a review. All reviews will be conducted by the Coastal Commission.

No action was taken on this item by the SAC at this time.
