reviewing and revising its Management Plan jointly with the Monterey Bay and Cordell

Bank National Marine Sanctuaries.

Directions: Point Reyes National Seashore is approximately 35 miles north of San Francisco. From

the north or south, take Highway 1/Shoreline Highway to Bear Valley Road just north of

Olema. Coming from the north, turn right onto Bear Valley Road. Coming from the

south, turn left onto Bear Valley Rd. The Red Barn is on the left, visible from the road.
