Administrative Business

The agenda was approved with no changes.

Motion to approve the August 2010 Key Meeting Outcomes:

Introduction of New Council Coordinator

Maria Brown announced the hire of Leslie Abramson as the new Sanctuary Advisory Council Coordinator.

Advisory Council Business

Finalize Council Charter Revisions

The council unanimously approved the final draft of the Council Charter with the following changes from the existing charter:

- Adoption of ONMS national policy on council term limits
- Amended language on guidelines for working group members and alternates
- Addition of US Fish and Wildlife Service as a voting, government seat
- Addition of Channel Islands National Marine Sanctuary as a non-voting, government seat

The council also discussed the addition of a youth seat and agreed that the SAC Coordinator would gather and provide more information on the experience of other councils, as well as national language provided for the charter.

2011 Retreat Date and Location

The council agreed to have a retreat in early October 2010, with a tour of the Cal Academy of Sciences. The council further proposed Mid-January 2011 for next year's retreat, so as to view elephant seals at Año Nuevo.

Superintendent's Report (Maria Brown)

The GFNMS 2nd and 3rd Quarter Superintendent's Report was distributed via email to members and is available at http://farallones.noaa.gov/manage/pdf/sac/10_12/supes_report.pdf. Maria Brown highlighted several items from the report and provided additional updates on the following:

- FY11 Budget and the Continuing Resolution: Due to budget constraints, there is a lack of funding for the RV Fulmar in 2011. The sanctuary and Farallones Marine Sanctuary Association are actively seeking alternative sources of funding.
- Tomales Bay Vessel Management Plan: The 37 recommendations in the plan have been accepted and the draft Vessel Management Plan is complete. At this point, the draft Environmental Assessment is being reviewed internally.
- Bolinas Lagoon Restoration Project: The sanctuary has a new project coordinator funded through FMSA, Kate Bimrose. Progress continues with the Kent Island Restoration beginning this summer, CalTrans habitat restoration project will begin in the fall of 2011, and a hydrographic survey is planned. A Town Hall meeting in March is planned to update the local community.
- Maverick's Surf Contest: Only one permit is being issued by Pillar Point Harbor to the Half Moon Bay Surf Group and no spectator access will be allowed on the hill or the beach. There will be a limit of 15 Motorized Personal Water Craft on water the day of the contest and all staff must have highly visible safety gear and a laminated permit displayed prominently.
- White Shark Permit Update: The sanctuary is currently reviewing the public comments on the Environmental Assessment of the Domeier permit.
- Overflight Regulations Update: George Clyde agreed to email information to the SAC Coordinator to be forwarded to council on proposed regulations, including Areas of Special Biological Significance (ASBS).

Public Comment

Sean Van Sommeran, from Pelagic Shark Research Foundation, submitted verbal comments against the use of barbed hooks to research white sharks. He requested to present to the council on the Año Nuevo project at our next meeting.

Tom Roth, from Representative Woolsey's office, submitted verbal comments on the prognosis for the Gulf of the Farallones Expansion bill, as included in the public lands omnibus before the Senate. Tom Roth is leaving Woolsey's office to work for State Senator Noreen Evans.

Enforcement Technical Advisory Committee (TAC) Update (Karen Revna)

The boat patrol guide is out on enforcement vessels and officers have been trained on how to use the guide. Overflight monitoring of the Sanctuary continues, but funding is sparse. We will be focusing

sanctuary efforts on the Coast Guard planes, not the Twin Otter. NOAA's Office of Law Enforcement and the US Coast Guard will be covering Maverick's Surf Contest.

<u>Informational Briefing on Estero Americano</u> (Michael Molland)

Michael Molland, representing Citizens Advocating for Roblar Rural Quality, asked the council for support in opposing the siting of a gravel mine on the Americano Creek. The proposed mine site is near the old, unlined Sonoma County landfill. Richard Charter suggested the council investigate the potential downstream impacts to sanctuary resources and possible council actions.

Richard Charter will chair the working group and it was agreed that a recommendation would be brought to the May meeting on how to proceed.

Working Group Update (Jackie Dragon)

Effects of Vessel Traffic on Sanctuary Resources

The working group has clarified its focus on the impacts of acoustic disturbance and shipstrikes on sanctuary resources. The working group will create a comprehensive report with recommendations for actions that will review impacts of anthropogenic acoustic environment and ship strikes. Recommendations will include research, education, outreach, policy and funding. The working group plans to meet 4-6 times between March 2011 and March 2012.
