RESOLUTION of the Greater Farallones National Marine Sanctuary Advisory Council (the council)

to Establish a Subcommittee on the San Francisco-Pacifica Exclusion Zone in the Northern Management Area (aka "Exclusion Zone", aka "Donut Hole")

Whereas, following a presentation from the San Francisco Zoo on their proposed plans to incorporate a coastal conservation zone into the zoo park (attachment), which sits adjacent to the San Francisco-Pacifica Exclusion Zone; and a presentation from San Francisco State University graduate student, Alyssa Ells (attachment), on outcomes and recommendations from the Symposium on the Connections between the San Francisco Bay and Greater Farallones National Marine Sanctuary, including a recommendation for expanding sanctuary boundaries to include the Exclusion Zone (noting that the area is an important habitat for humpback whales and other marine life); the council discussed the need for more information on the topic in order to make any potential recommendation to the sanctuary on the matter.

Whereas, the council has discussed this topic in the past and passed two resolutions in 2012 and 2016 related to the possible closure of the Exclusion Zone (attachments), the council expressed the need to revisit the matter as it stands today.

Therefore, be it resolved that the Greater Farallones National Marine Sanctuary Advisory Council will form a Subcommittee on the Exclusion Zone. The objective of the subcommittee is to research past information presented to the council, past actions taken by the sanctuary and current information related to the Exclusion Zone; and report back to the council for further discussion and potential action. Dominique Richard, Bruce Bowser, Jaime Jahncke, and Joe Fitting will sit on the subcommittee.
